Prof. Dr. Dr.habil.mult. Dr.h.c. Ilaria Ramelli, FRHistS (https://orcid.org/0000-0003-1479-4182; Web of Science Researcher ID AAM-9235-2020), earned two MAs (Classics with Specialisation in Early Christianity and Philosophy with Specialisation in History), a PhD (Classics and Early Christianity), a further Doctorate *honoris causa*, and a postdoctorate (Late Antiquity and Religion), as well as several Habilitations/Abilitazioni to Full Professor / Ordinarius / W3 (History of Philosophy, Classics and Ancient Greek Language and Literature). In the last twenty years she has been Young Researcher in Late Antiquity, Assistant in Roman History, in Ancient Historiography, Professor of History of the Roman Near East, and Fellow in Ancient Philosophy, with focus on classical and Patristic philosophy and early Christianity (Catholic University, Milan, 2003-), Senior Research Fellow in Ancient and Patristic Philosophy (Durham University), Senior Visiting Professor of Greek Thought at Harvard Divinity School and Boston University, Senior Visiting Professor of Church History (Columbia), Senior Research Fellow in Religion (Erfurt University), Visiting Research Fellow at the University of Oxford, Corpus Christi (senior fellowship), Senior Research Fellow in Hellenic Studies at Princeton University, Senior Research Fellow at Durham University, Institute for Advanced Studies and Classics (for the second time) and at the University of Oxford, Christ Church (Fowler Hamilton fellowship)—besides other senior fellowships and visiting professorships—and Full Professor of Theology and K. Britt endowed Chair (Graduate School of Theology, "Angelicum" University).

She is also Professor of Theology (Durham University, Hon., UK), Member (Senior) of the Centre for the Study of Platonism at the University of Cambridge, UK, the director of international research projects, and Humboldt Senior Fellow at Erfurt University, Max Weber Centre, and elected Senior Fellow at Bonn University. She has been elected Fellow of the Royal Historical Society and of the Forum for Advanced Studies G. Massa for Patristic Philosophy and Theology, associated with Cambridge University; distinguished Professor of Patristics and Church History (KUL, Hon.), Senior Research Fellow at the CEU Institute for Advanced Study; fellow of the International Plato Society, of the International Plato Society, the North American Patristics Society, the International Association for Patristic Studies, the Society of Biblical Literature, the Society for Classical Studies, the Humboldt Network of Outstanding Researchers, and of many other academic and scholarly societies.

She received, among many other prizes, two Agostino Gemelli Awards (1996; 1997); the Marcello Gigante Classics International Prize sponsored by the President of the Italian Republic and awarded at the Istituto Italiano per gli Studi Filosofici or Italian Institute for Philosophical Studies (2006); the inclusion in *Great Minds of the 21st Century* (2011), in the World Academy of Great Minds (2018), and in *2000 Outstanding Intellectuals of the 21st Century* (2011; 2014; 2017); eleven SBL Mentions for Distinguished Scholarly Service (2010; 2011; 2012; 2013; 2014; 2015; 2016; 2017; 2018; 2019; 2020), two Marie Curie Awards from the European Commission (2016, 2019-20), the Auguste Pavie Prize (Paris, 2017) and a Humboldt Research Award (*Forschungspreis*, 2017–), and nominations for the Goodwin Award of Merit from SCS, the Gerda Henkel Prize, the Holberg Prize from the Norwegian Parliament, and an AAR Award for Excellence in the Study of Religion, as well as for a number of endowed chairs at major Universities.

She is a member of many directive and scientific boards of scholarly series and journals (besides being engaged in the foundation of a new academic series and journal at the highest level) and of numerous international scholarly associations, and regularly serves as a peer reviewer for prestigious scientific series and journals, and as a scientific consultant in tenure/hiring evaluations for outstanding Universities, as well as in advanced research funding for leading international scholarly Foundations and first-rate Universities. She has been invited by an outstanding academic publisher to direct a history of late antique and patristic philosophy. She has also been, and is, a member of steering committees of scholarly societies and the director of many international seminars, workshops, conferences, and research projects.

She has taught courses and seminars, delivered invited lectures and conferences, including main and public lectures and lecture series, and held senior research fellowships and senior visiting professorships in numerous (including topmost) Universities in Europe, North America, and Israel; she has developed courses and study programs, including e-courses, has directed graduate programs, and supervised dissertations and research projects (MA, Licence, Doctoral and Postdoctoral/Habilitation dissertations, including at outstanding Universities), and has never interrupted an intense scholarly activity for some twenty-five years.

She has authored numerous books, articles, and reviews in leading scholarly journals and series, on ancient philosophy, especially Platonism and Stoicism, patristic theology and philosophy, early Christianity (Greek and Latin, but also Syriac, Coptic, and Armenian), the New Testament, the reception of Scripture, Hellenistic and Second-Temple Judaism, ancient Religions, imperial and late antiquity, classics, and the relationship between Christianity and classical culture.
