<sup>1</sup> Philosophy at Queen's had been polarised, for almost one hundred years, into what were perceived by outsiders as "protestant" and "catholic" departments. This situation was the worst instance of a problem which occurred in universities throughout the island of Ireland, where opposing philosophical traditions were represented in two separate philosophical associations which were also politically opposed. Within a few months of arriving in Ireland from England in 1976 I started working towards bringing together the two philosophical traditions in a way which would be synergistic rather than dangerous. As part of this process I ran at different times both associations (the "catholic" Irish Philosophical Society, mainly concerned with Continental philosophy, and the "protestant" Irish Philosophical Club, mainly concerned with Analytical philosophy) and later chaired the neutral National Committee for Philosophy of the Royal Irish Academy based in Dublin, where my last official action (2003-04) was to negotiate the new constitution for the Committee ensuring its continuation as a collaborative and tolerant body.

The two Queen's Departments, "Philosophy" and "Scholastic Philosophy", reflected in the same way the opposing Irish political traditions mapped on the opposing philosophical traditions. They did so through to their amalgamation in the new School in 1998 (within days of the "Good Friday Agreement") and for some time thereafter, with a very unfortunate impact on research and teaching quality and on their management. I took over the new School as its first Head with many research inactive staff, many close (but not close enough) to retirement, and where bickering had an unpleasant and occasionally dangerous political edge with strong paramilitary connections. It had also been expensive for the university in legal fees, and prior to becoming Head I was on a number of occasions consulted by Queen's on how to handle the legal difficulties the conflict produced. In the new research atmosphere which I introduced two previously difficult and inactive faculty members studied for and achieved their PhDs shortly before their retirements. In my six years as Head there were no further legal or paramilitary problems affecting the School.
