### **Short Bio:**

Nythamar “Nita” de Oliveira was born in Rio de Janeiro and after attending the Basic Program of Electronic Engineering at the Polytechnical School, earned a B.A. and Master’s degree in Theology at the Faculté de Théologie Réformée of Aix-en-Provence (1985, 1987), Master’s (Villanova University, 1990) and Ph. D. in Philosophy (State University of New York, 1994) and conducted postdoctoral research at the New School for Social Research (1997-98), London School of Economics (2004-05), Universität Kassel (2005, 2012), University of Toledo, Ohio (2007-08) and University of Miami (2014-15). He was associate professor at the Federal University of Santa Catarina (UFSC, 1994-99) and has been Visiting Professor at the University of Toledo, Ohio, since 2007-08, and Professor of Social Philosophy at the Pontifical Catholic University (PUCRS), Porto Alegre, Brazil, since 1999.

Nita has been a fellow researcher of the Alexander von Humboldt Stiftung (2004-05, 2012) and has been Brazilian National Research Council (CNPq) Fellow since 1995, acting as ad hoc consultant for CNPq and CAPES. Dr De Oliveira has been the Coordinator of the Assessment Area of Philosophy at the Brazilian Federal Agency for Support and Evaluation of Graduate Education (CAPES), during the 2018-22 term.

Professor De Oliveira created the Brazilian Society of Phenomenology in 1999, the Brazilian Center for Research on Democracy (2009) and currently coordinates the Research Group in Neurophilosophy at the Brain Institute (BraIns, since 2012), besides serving as member of the Clinical Bioethics Committee and as Editor-in-Chief of the philosophy journal *Veritas*. He has organized 13 international events and participated with paper presentation in more than 50 events, having supervised 18 postdoctoral internships, 32 Master’s theses and 31 doctoral dissertations (completed and publicly defended). He has published 5 books as an individual author (monographs), co-edited 11 volumes, and has over 50 articles published in Brazilian and international journals.
