"The Epistemic Condition of Blameworthiness, Reasonable Expectations, and Revisionary Implications"

My dissertation focuses on the topic of when ignorance excuses an agent from being blameworthy. I develop a novel defense of the reasonable expectations view (hereafter 'RE'). RE holds that ignorance excuses if and only if the agent could reasonably be expected to have avoided or corrected the ignorance. RE is highly plausible on its face; it captures the intuitive notion that fairness and desert matter for blameworthiness. However, a central objection to RE is that it takes too many cases of ignorance to excuse compared to our ordinary practice of blame. Moreover, the standard defense of RE overlooks the way that difficulty in knowing better matters for reasonable expectations. What can reasonably be expected of an agent is sensitive to how difficult it is for the agent to understand what their evidence justifies. Moreover, the sensitivity to difficulty results in RE having significantly revisionary implications due to the current circumstances of many real, non-ideal agents. However, I argue that the resulting revisionary implications are unproblematic, since they're due to applying ordinary practice's concern with desert and fairness to an empirically informed picture of many real, non-ideal agents.
