Katerina Kolozova (20 October 1969), PhD. is a professor of gender studies and philosophy of law at the University American College-Skopje and professor of policy studies and genarder studies at the Institute of Social Sciences Humanities, Skopje. Prof. Kolozova is also the director of the Institute of Social Sciences Humanities, Skopje. She is part of the permanent faculty of Singidunum University, Belgrade - Faculty of Media and Communications: Department of critical political studies, where she teaches political philosophy. In 2009, Kolozova was a visiting scholar at the Department of Rhetoric (Program of Critical Theory) at the University of California-Berkeley where she worked under the supervision of professor emerita Judith Butler. She is the author of "The Cut of the Real: Subjectivity in Poststucturalist Philosophy," NY: Columbia University Press: 2014, a book that critically engages with what she purports to be the crisis of the epistemic paradigm of the third wave feminism. Her latest monograph is published in October 2019 by Bloomsbury Academic - London (UK) titled Capitalism's Holocaust of Animals: A Non-Marxist Critique of Capital, Philosophy and Patriarchy (ISBN: 1350109681). Katerina Kolozova has been part of the faculty of University St. Cyril and Methodius-Skopje (ISPPI) since 2000 until 2013, having taught and supervised theses on MA and PhD level in media, communications and gender studies, further on continuing to supervise at the Faculty of Media and Communication-Belgrade as well as University of Sarajevo in the area of political philosophy. She has served as thesis external examiner at the University of Kingston-London, UK as well as at other European universities.

Apart from her academic portfolio, she has been an engaged policy analyst, advocate and activist, having acted as the lead researcher of several "Context Watch" analyses produced by ISSHS offering an overview in democratic, economic and socio-cultural progress of the country with gender and social inclusion as intersecting issues. She has been the leader of several multi-year projects on "illiberal democracy" governance in Macedonia and Europe, the issue of "state capture" as model of governance, depolarization of political discourse in the country and the region as precondition of surpassing populist governance, participation of women in politics and decision making, gender equity in local governance policy making, ethnic and women's

representation in the LGBTQUI movement in Macedonia. This is just a fraction of her vast portfolio in policy analysis and advocacy, and it is one that has always been accompanied by strong direct and public advocacy (including TV appearances, publishing of op-eds in Al Jazeera English, Open Democracy, Epohi-Athens, etc.): prof. Kolozova has acted as the lead author of the concept of advocacy and awareness raising campaign of ISSHS around the issue of "state capture" (a loose description of the method of governance in several cases of "illiberal democracy," most notably North Macedonia).

She has been the leader of several European and domestic projects in political studies and policy studies employing a multi-disciplinary approach combining gender studies, cultural studies, education studies, epistemology and philosophy Currently, she is leading an Erasmus+ Strategic partnership on innovation in curricula on integrative and research based curriculum building combining humanities, socials sciences and STEM, in partnership with Utrecht University and Sofia University. She is one of the founders and first co-chair of the Women's and Gender Studies Network of Southeast Europe as well as the founder and leader of the HESP supported multi-year ReSet project in gender and European studies in Southeast Europe. Kolozova was the lead researcher of one of the packages of the FP7 supported European project on Gender and Migration in Europe (GeMic, completed in 2010). She acted as the lead researcher for Macedonia on the issue of women with disabilities coordinated by the gender task force of UNDP coordinated from San Francisco (USA), to name a few.
