- advise the Minister and Secretary to the Department of Education and Training about principles of merit and equity to be applied in the teaching service;
- hear reviews and appeals in relation to decisions made under the Education and Training Reform Act 2006 (except Part 2.4, Division 9A - Unsatisfactory performance and Division 10 - Misconduct), or any other Act;
- advise the Minister or the Secretary about any matter referred to them by the Minister or the Secretary relating to merit and equity in the teaching service; and
- hear reviews and appeals in relation to any decision prescribed by the regulations to be a decision in respect of which there is a right of review or appeal to a Merit Protection Board.

#### Therapeutic Goods Administration - Specialist Advisor

The TGA is part of the Australian Government Department of Health, and is responsible for regulating therapeutic goods including medicines, biologicals and medical devices. The TGA administers the Therapeutic Goods Act 1989 (the Act), applying a risk management approach designed to ensure therapeutic goods supplied in Australia meet acceptable standards of quality, safety and efficacy (performance), when necessary. The work of the TGA is based on applying scientific and clinical expertise to decision-making, to ensure that the benefits to consumers outweigh any risks associated with the use of therapeutic goods.

Bail Justice

Bail Justices are appointed by the Governor in Council under section 14 of the Honorary Justices Act 2014 and conduct:

remand hearings in respect of adults who are held in police custody under the Bail Act 1977;

- remand hearings involving children who are held in police custody and applications for Interim Accommodation Orders under the Children, Youth and Families Act 2005; and
- Bail Justices also have the power to witness statutory declarations and receive affidavits within Victoria.
