Dissertation

Rational Intuition: Intuition is the key to solving many persistent and difficult philosophical problems, such as skepticism about the external world, about induction, and about abstract objects. In addition, intuition is the principal source of evidence in ethics. I begin by defending a new theory of rational and ethical intuition, distinguishing, by subject matter, modal, normative (including ethical), and abstract intuitions. I develop an irreducibly normative, internalistic theory of epistemic justification, according to which epistemic justification arises from a subject's internally accessible awareness. I defend a new theory of the metaphysics of rational intuition. Finally, I present new arguments to justify rational intuition, arguments that do not depend upon controversial assumptions concerning epistemic circularity, self-evidence, or epistemic conservatism, but instead go forward from the premise that epistemic agents are unjustified in accepting self-defeating positions.
