TEACHING EXPERIENCE

For five years in Oxford I taught a wide range of topics in small tutorials with undergraduates and graduates, and also gave large logic classes. From 1980–81 I stood in for J.R.Lucas at Merton College for one year, teaching the standard Tutorial Fellow's load of 12–14 contact hours per week. At Tulane I taught two courses per semester, typically two elementary logic courses and two advanced courses, in logic, or philosophy of language, or metaphysics. I had a similar profile at CU. Graduate courses are listed *ad fin.*

ADMINISTRATIVE EXPERIENCE

From 1999 to 2006 I was Secretary of the Tulane University Senate, and an elected or *ex officio* member of the President's Faculty Advisory Committee from 1992–2006, with two one-year breaks. I was Chair of the Provost Search Committee (2001–2). For 1995–9 I was chair of the Senate Budget Review Committee. In this period I was also Co-Chair of Tulane 2000, the university's mid-90's long-term planning effort, and a member of the Search Committee for Tulane President, 1997–8. 1992–4: Vice Chair of the University Senate, Chair of the Senate Committees on Educational Policy, Committee on Committees, President's Faculty Advisory Committee, and member of the Senate Budget Review Committee. I was Acting Chair of the Philosophy Department (1991–92), Associate Chair and Director of Graduate Studies (1989–92, 99–02), and Department Computer Liaison Officer

(from the dawn of the information age). Outside Tulane, I was Co-chair (with Charles Parsons) of the Program Committee for the Association of Symbolic Logic meeting in New Orleans in May 1999. At Colorado, I have been Chair of the Philosophy Department and a member of the College Personnel Committee, and was Department Executive Officer in the Philosophy Department for calendar 2014 and '15.

RESEARCH INTERESTS

My main interests, in descending order, are in philosophy of language, especially in the semantics of intensional verbs; in analytic metaphysics, especially in issues involving modality; in epistemology, especially in scepticism; in philosophy of mind, especially in topics that bear on intensionality (nature of psychological explanation, cognitive aspects of reference, etc.); in philosophy of science, especially in issues involving space and time; and in aesthetics, mainly philosophy of music. My most recent monograph, *Attitude Problems*, was on intensionality and was published in 2006 by Oxford University Press. I am also (paused) in the process of making a new edition of *The Metaphysics of Modality*.
