In my research, I relate Anton Wilhelm Amo (c. 1700 - c. 1750), Europe's first African Ph.D. in philosophy (c. 1734), to philosophy through Descartes and religion through Pietism, Orthodox Lutheranism, and the *Aufklärer* together with the treatment of human difference in the work of Robert Boyle, Leo Africanus, Diderot and their contemporaries. My project aids in addressing (1) the lack of diversity in the philosophical canon and (2) the insufficient historical analysis of various designations of human difference.
