Summary of project:

The aim of the project was to develop and test a new approach to teaching critical thinking, making use of cutting-edge teaching methods such as Argument Mapping software, Peer Instruction, and Personalised System of Instruction, also known as 'Mastery Learning'. A course was developed the aim of which was, in part, to train intelligence analysts in critical thinking and reasoning. The project was funded by IARPA (Intelligence Advanced Research Projects Activity) in the USA, and was an international collaboration involving researchers in Australia, the USA, the UK and Canada.
