Course explores founding myths, dramas, histories, rituals, and poetry of oral/indigenous traditions, western traditions, and eastern traditions. Satisfies Gen Ed.

CLST 1000: Great Books East and West

Course is structured as comparative epics. We read the Iliad, Odyssey, bits of the Heike Monogatari and lately Monkey, Journey to the West, exploring the themes which resonated with ancient audiences and continue to resonate with us. Satisfies Gen Ed.

REL 2001: Search for Meaning

Course examines religious themes in world literatures.

HONS 2100: Religion, Nationalism, and Violence. Honors course.

REL 3000: Religion, Sacrifice, and Violence

Course applies classical theories of religious violence to selected events, stories, or films.

Textbook is the *Princeton Readings on Religion and Violence*, eds. Juergensmeyer and Kitts.

CLST 3100: Gender in Classical Myth, Religion, and Literature

Course explores gender in western classical imagination, starting with Minoan art and the Homeric epics, continuing through the Greek and Gnostic Gospels. Satisfies minors in REL, CLST, EWCS, WS, and HUM, as well as E-W Hum major.

HIST 3101: Greek History to Alexander.

This was a lot of work and a lot of fun. Taught for first time in spring 2023.

REL 3151: Bible as Literature

Course explores biblical stories for their possible significance in ancient times as well as for their resonance today.

REL 3200: Abrahamic Traditions

Course explores religious traditions of the ancient Near East, Judaism, Christianity, and Islam, as well as the contemporary interactions and conflicts among the last three. Satisfies REL minor, E-W Hum major.

REL 3310: Asian Traditions

Survey of the literature, history, and cultural traditions associated with Asian religions, such as Hinduism, Jainism, Buddhism, Bo, Confucianism, Daoism, Shinto, and numerous folk traditions. Course begins in ancient India and expands into Nepal, Tibet, Sri Lanka, China, Korea, Japan, and Hawai'i. Satisfies REL minor, E-W Hum major, and Asian Studies major.

REL 3600: War in World Religions

Course explores ideological coupling of religion and war from the earliest times through the present. Focus is on evidence presented in literature and art. Satisfies REL minor, E-W Hum major.

HUM 3601: Mythology

Course explores a variety of themes in ancient Greek, Roman, and Near Eastern mythology. Satisfies REL, CLST, HUM, and EWCS minors, E-W Hum major.

REL 3700: Gender in the Bible

Course explores gender in biblical imagination. Satisfies REL minor, Women's Studies minor, E-W Hum major, ENG major.

REL 4002/6002: Religion, Sustainability, and Globalization.

Course is an overview of the various traditional religious attitudes toward environmental issues, and in depth study of particular issues emergent in the recent decades of globalization. Satisfies REL minor and MGLS majors and grad program. This course is retired.

[HUM 1000: Introduction to Humanities

This course is retired. Used to explore classical texts and themes from east and west.

WRI 1200: This is a research and writing course.]
