Abstract:     My doctoral dissertation argued that, for Heraclitus, the real unity of reality can only be grasped from a state unconditioned by the “idiosyncrasies” inherent in human perception, thought and preferences. He uses the unity of opposites as part of his method for achieving this state. The unity of opposites is a structural principle basic both to human thought and to the view of reality with which it is associated. Yet when applied both consistently and globally, this principle undermines both itself and the human perspective that it structures. Through an analysis of Heraclitus’ use of perspective juxtapositions, I showed that the logos’ method of evoking the unity of opposites aims at a (temporary) collapse of perspective and a consequent apprehension of reality as a unity without oppositions and differentiations.
