Research project: States and the Limits of Feasibility: Enforcement, Morality and Possibility

Summary: States make us do things; they enforce our acting in certain ways. What is more, this seems to be an essential element of statehood. My thesis explores justifications for the kind of general and exclusive moral entitlement to enforce that states claim, and in particular the role that feasibility considerations play in these. I argue that premises about the infeasibility of alternatives to a state's enforcement are essential to the success of any such justification. States' permission to enforce can be justified, if at all, in response to the unfortunate circumstances in which we find ourselves. I develop a general account of the concept of feasibility that raises some important, but difficult questions, for thinking about the justification of state enforcement. Understanding the dependence of state legitimacy on facts about feasibility, I argue, helps illuminate how we ought to think about and treat the state enforcement we face in the real world.
