PhD Research:

My PhD thesis focused on examining philosophical and psychological theories of understanding other. In particular, I examined how children develop the skills to engage with and understand others. Drawing on empirical data and theoretical work, I examined the concept and practice of empathy within therapeutic contexts. Additionally, my work aimed to further develop the neurodiversity paradigm, and our understanding of autism and the relationship autistic individuals have with neurotypical institutions and social practices. Much of my work was informed by narrative approaches to understanding minds and our interactiosn with our sociocultural environments. Essentially, my research work is centered around empathy, arguing that there are advantages to conceiving of empathy, as enactive and exploratory in the sense that when we empathize with others we understand them in a deeper, richer way, by exploring their self-authored narratives.

Current Research:

My most recent research has focused on developing alternative models for disability, drawing on work from the neurodiversity paradigm and mad studies literature. As opposed to the orthodox medical model approach, I argue that we need to embrace an ecological functional model, that recognizes disability as a phenomenon that can only be understood across the individual and social levels. As such, cognitive and physical disabilities are not necessarily pathological. Instead, in order to understand disability, we also need to examine the socio-material conditions of our societies and institutions.
