Dissertation Abstract

In his early mature writings, Leibniz derives his main metaphysical claims from a distinctive theory of truth, known as the predicate-in-notion principle (the PIN), according to which a proposition is true if and only if its subject contains its predicate. To apply a later term, coined by Kant, to Leibniz's view of truth, Leibniz thought that truth was just analyticity. My dissertation is an exploration of the PIN

and its role in Leibniz's metaphysics. I argue that the PIN is better motivated than it might seem, and I reconstruct Leibniz's derivations of some of his trademark metaphysical claims from it, including his account of substance and his claim that substances do not interact.

Many scholars have found the PIN puzzling. They have wondered why Leibniz held it, and they have had their doubts about whether his core metaphysical doctrines really follow from it. In contrast to the logicist view of Bertrand Russell and especially Louis Couturat from the early twentieth century, according to which the PIN is the single most important key to understanding Leibniz's metaphysics, more recent scholarship has deemphasized its role.

This more recent scholarship has made a valuable contribution to the project of understanding Leibniz by pointing out the limitations of the role of the PIN as a unifying factor in his philosophy and drawing attention to Leibniz's other ways of arguing for his metaphysical views in later writings. However, in my dissertation, I argue that the PIN, and Leibniz's derivation of his metaphysics from it in his early mature writings, remain important to understanding his philosophy. I take up the puzzle of the PIN anew and argue that not everything interesting about it has yet been noticed in Leibniz scholarship.

In particular, I reconstruct a serious philosophical argument for the PIN that Leibniz offers in his short work "On Contingency"; I argue that Leibniz has the resources in his philosophy to vindicate his explanation of why the PIN does not imply that all truths are necessary against various objections raised by recent scholars; and I provide new reconstructions of Leibniz's derivations of some of his trademark metaphysical claims from the PIN, reconstructions that avoid difficulties that arise for earlier attempts to understand these derivations. I also relate this to Leibniz's work in formal logic, arguing that one of his formal systems fits well with my understanding of his derivation of his account of substance from his account of truth.
